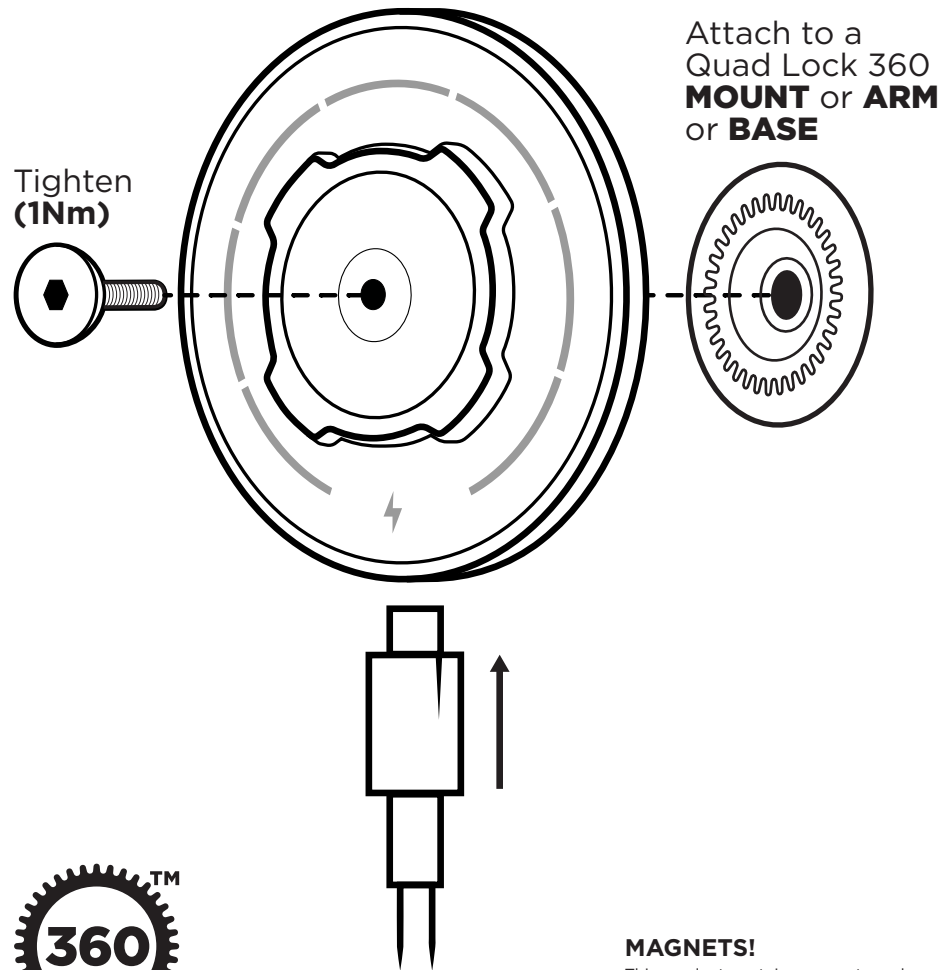

FC Annex Products Pty Ltd, Australia, declares that the products "MAG Wireless Charger Head, Model No. QL-3954-M", complies with part 15 of the FCC Rules. NOTE: The "MAG Wireless Charger Head" has been tested and found to comply with the limits for a Class B device, pursuant to Part 15 of the FCC Rules and has been assigned FCC ID: 2AQU9-QLH2.
