

## MAG HEAD WIRELESS CHARGER

### MAGNETS!

This product contains magnets and components that generate strong electromagnetic fields. Keep your Quad Lock product a safe distance away from any sensitive or implanted medical devices. Consult with your medical practitioner or device manufacturer before use, or if you suspect the product is interfering with your device.

**FC** Annex Products Pty Ltd, Australia, declares that the products "MAG Wireless Charger Head, Model No. QL-3954-M", complies with part 15 of the FCC Rules. 
